- Cash prizes awarded to artists with original work in each category. No buy/sell items.
- Work exhibited must be tasteful and in keeping with a family-oriented atmosphere. It is the exclusive
  right and responsibility of the Canandaigua Christkindl Market committee to require an artist to remove
  any work not in compliance.
- All displays will be inspected prior to opening and at intervals throughout the show.
- All artists are requested to submit a donated item to our raffle which is located at the entrance of our market... it's the first thing market-goers see!
- All display items, light fixtures, inventory, chairs, etc. must be kept within your 10'x10' booth space.
- No subletting or sharing of booth space.
- Details will follow regarding venue layout and parking.
