- Application deadline is June 1, 2024
- Application is juried based on recent digital images of original work. Three images of work, plus one of set-up, to be sent to CCM14424@GMAIL.COM - **Image quality matters - PHOTOS-CD's-DVD's NOT ACCEPTED.**
- Cash prizes awarded to artists with original work in each category. **No buy/sell items.**
- Work exhibited must be tasteful and in keeping with a family-oriented atmosphere. It is the exclusive right and responsibility of the Canandaigua Christkindl Market committee to require an artist to remove any work not in compliance.
- All displays will be inspected prior to opening and at intervals throughout the show. All display items, light fixtures, inventory, chairs, etc. must be within your 10'x10' booth space.
- No subletting or sharing of booth space.
- Details will follow regarding venue layout and parking.
- No smoking or pets allowed on grounds.
